Privacy Policy

1. Introduction

The Home Counties Association of Spiritual Healers is a charitable association set up to promote, practice and maintain a high standard in the application of spiritual healing.

2. What information we hold

- 2.1. Information that relates directly to you, such as:
 - 2.1.1. Personal contact details
 - 2.1.2. Demographic information
 - 2.1.3. Training records and client testimonials that you have submitted
 - 2.1.4. Digital and paper correspondence with us
 - 2.1.5. Details of sufficient insurance to be able to carry out the practice of spiritual healing
- 2.2. Information relating to you.

3. How we might use your personal information

- 3.1. To keep in contact with you
- 3.2. To provide you with relevant information that may be of use to you
- 3.3. With your permission, ask contacts in our network to connect with you, or connect you with those requiring spiritual healing in your area
- 3.4. Inform you of the date of the association's Annual General Meeting and the date of any Extraordinary General Meeting held
- 3.5. Ways we may contact you include; email, post, telephone, SMS text message or social media
- 3.6. Keep you updated about amendments to the association's code of conduct and any other relevant changes that we feel necessary.

4. How we gather your personal information

- 4.1. Provided by you directly to us
- 4.2. Publicly accessible information
- 4.3. When you visit our websites
- 4.4. Collected from our surveys and questionnaires.

5. Your data protection rights

- 5.2. You have rights under the Data Protection Act 1998, these can also be found on the ICO website

5.3. To update your details or to exercise your other rights under these regulations, please provide your request in writing to the Chairperson's address or email info@numbercrunchingltd.co.uk. We may require you to provide proof of identification.

6. Cookies

- 6.1. A cookie is a small piece of information that is placed on your computer when you visit certain websites
- 6.2. We use third party analytics cookies, which are placed by or on behalf of companies such as Google;
 - 6.2.1. They are used for statistical analysis by us to look at the number of and types of visitors to our websites 6.2.2. We have no access to personal information from these third-party cookies
 - 6.2.3. The third-party organisations that place cookies have their own strict privacy policies
- 6.3. You can turn off cookies within your web browser:

6.3.1.To do this look at the 'help' menu on your browser

6.3.2. Switching off cookies will not restrict your use of our websites.

7. Protecting your personal information

- 7.1. Our primary store of your personal information is stored securely at the premises of the Membership Secretary, any records stored on a computer are stored on servers which are password protected and not directly accessible from the internet
- 7.2. Your personal information may also be stored in the wider internet under secure cloud-based storage services, such as Dropbox, Google Drive and Microsoft One Drive
- 7.3. We invest in high-quality security to protect your privacy. No information transmission over the internet can be entirely secure, and therefore we cannot guarantee the security of your personal information. Any information that you send is at your own risk. However, once we have received your personal information we use strict procedures to protect the security of your personal information
- 7.4. Any paper copies of your personal information are stored within our premises and are kept with us or stored securely
- 7.5. Laptops and mobile devices are password protected but not necessarily encrypted
- 7.6. Any password you provide when registering with our websites is encrypted to ensure protection against unauthorised access; we do not have access to read these passwords
- 7.7. Your personal information provided to our websites is stored securely on our web server
- 7.8. Where we store your information electronically:
 - 7.8.1.Our in-house data storage where your personal information may be stored is in the European Economic Area (EEA) or the UK
 - 7.8.2. The personal information that we collect from you may also be uploaded and stored outside the European Economic Area (EEA) in order to carry out the activities listed in 'Use of Your Personal information' section above. For example, we are unable to dictate the storage location used by Dropbox and Google Drive file storage services.

8. Disclosing your personal information

- 8.1. We do not pass your personal information to third parties for marketing purposes without your permission
- 8.2. We may disclose your personal information to fulfil a contract with a third-party client, but only where your consent has been provided
- 8.3. We sometimes share your personal information with subcontractors providing products and services on our behalf
- 8.4. Our subcontractors may have access to your personal information, this will only be used to provide our services
- 8.5. We disclose details of all financial transactions with our auditor for reporting purposes
- 8.6. We may disclose your personal information to another healing association if we were to close HCASH, if we are required to do so
- 8.7. We may disclose your personal information, in response to orders by the government or law enforcement authorities.
- 8.8. We will share your information with Balens Insurance Brokers, solely in the respect of your insurance cover for spiritual healing with our association, as detailed in our Constitution and Code of Conduct.

9. How long we store your personal information

- 9.1. If you are a member of the association, we may retain your personal information for a period of 7 years to ensure we are able to comply with any contractual, legal, audit, investigation and regulatory requirements
- 9.2. If we have an ongoing relationship with you then we may retain your personal information for longer than 9 years
- 9.3. If you are not a member, we may keep your personal information for up to 7 years following our last contact with you.
